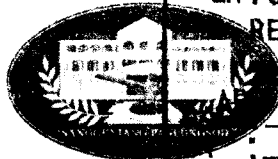

AN ORDINANCE REVERTING THE ALLOCATION PROVIDED FOR THE FOLLOWING POSITIONS: ONE (1) SUPERVISING AGRICULTURIST, ONE (1) SENIOR AGRICULTURIST, ONE (1) ACCOUNTANT II, AND ONE (1) SOCIAL WELFARE OFFICER I TO BE RE-ALLOCATED TO REPRODUCTION MACHINE OPERATOR III, AND MESSENGER OF THE CITY ADMINISTRATOR'S OFFICE; PUBLIC HEALTH NURSE II OF THE CITY HEALTH OFFICE; AND ADMINISTRATIVE OFFICER I (CO-TERMINUS), REPRODUCTION MACHINE OPERATOR III, LOCAL LEGISLATIVE STAFF EMPLOYEE II, ADMINISTRATIVE AIDE III (UW II) AND ADMINISTRATIVE AIDE III (UW II) OF THE SANGGUNIANG PANLUNGSOD OFFICE, CITY OF VALENCIA, BUKIDNON.

Prefatory Statement

WHEREAS, there are vacant positions with corresponding budget allocation in the City Agriculture Office, City Accounting Office, and City Social Welfare and Development Office but the same are not filled up;

WHEREAS, based on the Personnel Schedule of the respective Departments, said vacant positions, Supervising Agriculturist is under Crop Services Division, Senior Agriculturist is under HVCC Vegetable Section, Accountant II is under Book Keeping of Services Section and Social Welfare Officer I under Distressed PWD's and Senior Citizen Section;

WHEREAS, the funds allocated of said positions in this Budget Year has to be reverted considering the positions remained dormant and has not been filled in due to lack of qualified applicants;

WHEREAS, based on the above premise, the fund shall be utilized to fund the positions mentioned above under the City Administrator's Office, City Health Office and Sangguniang Panlungsod Office;

WHEREAS, the appointment of said positions is effective on April 2014;

BE IT ORDAINED, by the Sangguniang Panlungsod in the City of Valencia, Bukidnon, in a regular session assembled, that:

SECTION I. TITLE. This ordinance shall be known as "An Ordinance reverting the allocation provided for the following positions: One (1) Supervising Agriculturist, One (1) Senior Agriculturist, One (1) Accountant II, and One (1) Social Welfare Officer I to be re-allocated to Reproduction Machine Operator III and Messenger of the City Administrator's Office; Public Health Nurse II of the City Health Office; and Administrative Officer I (co-terminus), Reproduction Machine Operator III, Local Legislative Staff Employee II, Administrative Aide III (UW II) and Administrative Aide III (UW II) of the Sangguniang Panlungsod Office, City of Valencia, Bukidnon.

SECTION II. POSITIONS TO BE UNFUNDED. Positions to be unfunded under the Executive Department are the following:




SECTION V. EFFECTIVITY CLAUSE. This Ordinance shall take effect after 10 days of posting in at least two (2) public conspicuous places.


