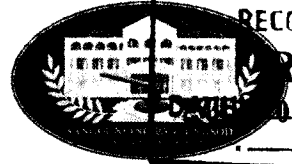

### ORDINANCE NO. 40-2014 (37<sup>th</sup> Regular Session)

**AN ORDINANCE AMENDING ORDINANCE NO. 37-2014 BY ADDING FIFTY TWO THOUSAND PESOS (PHP52,000.00) FROM OTHER MAINTENANCE AND OPERATING EXPENSES (OMOE), UNDER MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) MAKING A TOTAL REVERTED AMOUNT OF ONE HUNDRED TWO THOUSAND PESOS (PHP102,000.00) FOR THE PROCUREMENT OF SERVICE VEHICLE UNDER CAPITAL OUTLAY OF THE CITY AGRICULTURE OFFICE.**

#### Explanatory Note

The allocation for the Service Vehicle under the Capital Outlay of the Office of the City Agriculture is not sufficient to procure a vehicle with an engine displacement below 3.0 and a 4X4 pick-up type, hence the amount of One Hundred Two Thousand Pesos (Php102,000.00) will be reverted to augment the funding for the said purchase.

**BE IT ORDAINED**, by the Sangguniang Panlungsod in the City of Valencia, Bukidnon, in a regular session assembled, that:

**SECTION I. TITLE.** This ordinance shall be known as "An ordinance amending Ordinance No. 37-2014 by adding Fifty Two Thousand Pesos (Php52,000.00) from Other Maintenance and Operating Expenses (OMOE), under Maintenance and Other Operating Expenses (MOOE) making a total reverted amount of One Hundred Two Thousand Pesos (Php102,000.00) for the Procurement of Service Vehicle under Capital Outlay of the City Agriculture Office".


**SECTION II. AMENDMENT.** Section III of Ordinance No. 37-2014 is hereby amended, specified below:


**SECTION III. EFFECTIVITY CLAUSE.** This Ordinance shall take effect immediately upon its approval.
