**ORDINANCE NO. 24-2014**  
(22<sup>nd</sup> Regular Session)

**AN ORDINANCE APPROVING THE FIVE PERCENT (5%) GENDER AND DEVELOPMENT (GAD) OF THE CITY ANNUAL BUDGET FOR CALENDAR YEAR 2014 IN THE AMOUNT OF THIRTY SIX MILLION THREE HUNDRED THIRTY TWO THOUSAND EIGHT HUNDRED FOUR PESOS (PHP 36,332,804.00).**

**BE IT ORDAINED**, by the Sangguniang Panlungsod in the City of Valencia, Bukidnon in a regular session assembled, that:

**SECTION I.** The amount Thirty Six Million Three Hundred Thirty Two Thousand Eight Hundred Four Pesos (Php 36,332,804.00) is hereby appropriated in the City Treasury to provide for the Executive Budget, 5% Gender and Development (GAD) of this city for Calendar Year 2014.

### SECTION III. PROVISIONS.

a. The 5% Gender and Development (GAD) Budget for Calendar Year 2014 in the amount of Thirty Six Million Three Hundred Thirty Two Thousand Eight Hundred Four Pesos (Php36,332,804.00) is prepared following the provisions of Sections 16 and 17 of the Local Government Code of 1991 and other issuances governing the same.

b. The programs, projects and activities under 5% Gender and Development (GAD) appropriations are the GAD concerns of the City Government of Valencia.

c. The list of Programs, Projects and Activities (PPA's) of the lumped allocation of each item of expenditure must be submitted to the Sangguniang Panlungsod prior to the implementation of said PPA's.

### SECTION IV. RESPONSIBILITY.

The disbursement of funds should be in compliance of the existing budgeting, accounting laws, rules and regulations and on the provisions of the Local Government Code of 1991. The responsibility for the execution and accountability therefore shall be vested primarily in the Local Chief Executive.


### SECTION V. EFFECTIVITY CLAUSE.

This Ordinance shall take effect immediately upon its approval.
