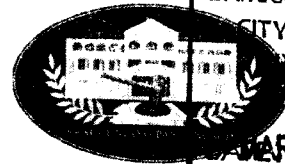

BE IT ORDAINED, by the Sangguniang Panlungsod in the City of Valencia, in a regular session assembled, that:

SECTION I. TITLE. This ordinance shall be known as "An Ordinance approving the Supplemental Budget of the General Fund for Fiscal Year 2014 in the amount of Twelve Million Five Hundred Eighty Four Thousand Five Hundred Fifteen Pesos and 5/100 (Php12,584,515.05) to fund the various programs, projects and activities (PPAs) of this Administration City of Valencia, Bukidnon,"

SECTION II. SOURCE OF FUNDS. The funding source for Supplemental Budget is from the Surplus of Calendar Year 2013.

SECTION III. APPROPRIATION OF FUNDS. The available amount of Twelve Million Five Hundred Eighty Four Thousand Five Hundred Fifteen Pesos and 5/100 (P12, 584, 515.05) is hereby appropriated, to wit:

SECTION V. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon its approval.




