AN ORDINANCE ADOPTING THE DOWNWARD ADJUSTMENT OF THE MOTORELA FARE WITHIN THE CITY, PURSUANT TO THE RECOMMENDATION OF THE CITY MOTORELA FRANCHISING AND REGULATORY BOARD (CMFRB).

Explanatory Note

WHEREAS, it was discussed during the City Motorela Franchising and Regulatory Board (CMFRB) regular meeting held on January 22, 2015 at SP Session Hall, the clamor of the passengers regarding fare adjustment since there have been a significant change in the prices of Gasoline and Diesel since October 6, 2014;

NOW, THEREFORE, on motion of Honorable Oliver Owen L. Garcia, duly seconded by Honorable Glenn P. Peduche, Honorable Eduardo D. Chan and Honorable Helen T. Bernal,

BE IT RESOLVED, as it is hereby resolved, to pass the herein Ordinance thus:

BE IT ORDAINED by the Sangguniang Panlungsod in the City of Valencia, Bukidnon in a regular session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known and cited as, "AN ORDINANCE ADOPTING THE DOWNWARD ADJUSTMENT OF THE MOTORELA FARE WITHIN THE CITY, PURSUANT TO THE RECOMMENDATION OF THE CITY MOTORELA FRANCHISING AND REGULATORY BOARD (CMFRB)".

SECTION 2. AUTHORITY. The fare adjustment was recommended by the City Franchising and Regulatory Board (CMFRB) through its Board Resolution No. 16-2015 dated January 22, 2015. This special body created per Ordinance No. 2004-04 (N), tasked to approve and regulate fare for motorelas operating in the City.

SECTION 3. RATE ADJUSTMENT. There will be a fare adjustments based on the price bracket of gasoline and diesel, to wit:

Price of Gasoline/Diesel per Liter	Fare
Php 30.00 - 50.00	Php 7.00
Php 50.05 - 70.00	Php 8.00
Php 70.05 - upward	subject for approval by the CMFRB

SECTION 4. FARE MATRIX. The motorela fare downward adjustment is hereby fixed according to the schedule herein provided as follows;

SECTION 5. POSTING. The City Motorela Franchising and Regulatory Board (CMFRB) is hereby authorized to reproduce and distribute the same to all motorela drivers and operators to be posted inside the motorela for the guidance of the public.

SECTION 6. SEPARABILITY CLAUSE. Any provision of this ordinance found unconstitutional or declared illegal by the competent court, the validity of the other provisions shall be deemed not affected and shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE. All ordinances and resolutions inconsistent or in conflict with the provisions of this ordinance are hereby repealed.


SECTION 8. PENALTY CLAUSE. Any motorela drivers and operators found violating Section 5 of this ordinance be penalized according to the following:

Non-Posting	₱ 500.00
Non-Observance of the fare matrix	
1 st Offense	500.00
2 nd Offense	1000.00
3 rd Offense	cancellation or revocation of the franchise/Permit



PASSED AND ENACTED this 27th day of January 2015.


