**AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 91-2012, REGULATING THE OPERATIONS OF MOTORELA PROVIDING GUIDELINES FOR THE GRANT OF FRANCHISE AND FIXING THE LICENSE AND PERMIT FEES THEREOF BY DESIGNATING NEW MOTORELA BODY NUMBER ALLOCATION TO EACH MOTORELA ASSOCIATION.**

**Prefatory Statement**

Per record, the existing Motorela units operating in the City of Valencia is One Thousand Three Hundred (1,300). To closely monitor and identify illegal motorela operators, the City Motorela Franchising Regulatory Board (CMFRB) has passed Resolution No. 08, series of 2014 indicating thereto the new motorela body numbering for the Seven (7) Motorela Associations. The said resolution was discussed by the joint Committee on Public Transportation and Utilities, and Laws, Rules, Privileges, Ordinances and Human Rights and has recommended to amend Section 2 of Ordinance No. 91-2012 for the new motorela body number allocation.

**BE IT ORDAINED**, by the Sangguniang Panlungsod in the City of Valencia, Bukidnon in a regular session assembled, that:

**SECTION 1. TITLE.** This ordinance shall be known "An ordinance amending Section 2 of Ordinance No. 91-2012, regulating the operations of motorela providing guidelines for the grant of franchise and fixing the license and permit fees thereof by designating new motorela body number allocation to each motorela association."

**SECTION 2. AMENDMENT**

*SECTION 2 of Ordinance No. 91-2012 is hereby amended to read:*

*The existing One Thousand Three Hundred (1,300) Motorela body numbers shall be divided among the Seven (7) Motorela Associations as follows:*

| 6. VMODA                   | 941 - 1,120                            |
| 7. VUMODA                  | 1,121 - 1,300                          |


**SECTION 3. EFFECTIVITY**

This ordinance shall take effect on the first day of January 2015.
